



MEMBERSHIP FEE SCHEDULE



Valid from: July 1, 2017-June 30, 2018

Prior year account balances for ice and fundraising must be paid prior to registration. Membership fees are not prorated. Membership renewal forms are due no later than 6/29. Membership forms with check made payable to KFSC may be left at the rink in a sealed envelope or mailed to 380 Marlboro St Keene. Any membership form received after 6pm on 6/29 will be required to pay a late fee of \$25.00.

Full Membership (HOME CLUB MEMBER)

For skaters and coaches who regularly skate on KFSC ice and/or represent KFSC at competitions, test sessions, and consider KFSC their home club.

\$150 – First family member \$75 – Second, Third or Fourth family member (each additional member after the first is \$75)

Associate Membership (REGISTERED WITH ANOTHER CLUB)

For skaters and coaches who regularly skate on KFSC ice and/or represent KFSC at competitions, test sessions, and do not consider KFSC their home club.

\$75– Per individual

Introductory Membership

For skaters who have not previously registered as a full member and skate regularly on KFSC ice, may compete and participate in test sessions, and consider KFSC their home club. This membership is valid for one year, and then must register as a full member.

\$75 – Per Individual

Collegiate Membership

For any KFSC member who skates or coaches regularly on KFSC ice and/or represents KFSC at competitions or test sessions and considers KFSC their home club. This is considered a 4 year membership fee.

\$100 – Per individual (a one-time 4 year membership fee)

Non-skating Board Member

\$25 – Per Individual

Late Fees:

Late fees do not apply to new memberships. KFSC registers skaters with USFS using a one-time, on-line “batch” transaction. If your registration is late, it requires us to make a single transaction. USFS charges administrative fees to process single registrations.

Late Registrations = \$25.00 KFSC late fee + the USFS administrative fee
