Keene Figure Skating Club Waiver and Release of Liability

As a condition of being allowed to participate in Keene Figure Skating Club activities, I represent that I understand the nature of figure skating and off-ice training activities ("activity") and that I am qualified, in good health and in proper physical condition to participate in such "activity". I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the "activity".

I fully understand that this "activity" involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the "activity", the conditions in which the "activity" takes place, or the negligence of the "releasees" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the "activity".

I HEREBY RELEASE, discharge, and covenant not to sue the Keene Figure Skating Club, United States Figure Skating (USFS), USFS or club directors, officers, administrators, sponsors, volunteers, agents, employees, staff, instructors, trainers, other participants and if applicable, owners and lessors of premises on which the "activity" takes place (each considered one of the **"RELEASEES"** herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be **CAUSED** in whole or in part **BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE**, including negligent medical care; and I further agree that if, despite this release, waiver of liability, and assumption of risk, I, or anyone on my behalf, makes a claim against any of the **RELEASEES**, I will indemnify, save, and hold harmless each of the **RELEASEES** from any loss, liability, damage, or cost which any may incur as the result of such claim.

The Keene Figure Skating Club has the right, but not the obligation, to provide rules, regulations and/or ice monitors for Club Ice. We hereby acknowledge that the Keene Figure Skating Club shall not be responsible for the supervision of the members at Club Ice.

I have read this **RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT**, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.

Introductory Membership: \$100.00 Introductory Membership is a full membership available to an individual who does not or has not previously belonged to a USFS club. This special membership is for one year and any year after that will be at regular club rates. Renewing members and any skater already affiliated with another club do not qualify for this offer.

Full Membership: \$150.00 Full Membership of the Keene FSC is available to an individual who wishes to participate in all exhibitions/events sponsored by the Club including Club parties, Ice shows and Annual Skating Banquet (additional fees may apply). Keene Ice Arena has offered a \$1.00 off each contracted Freestyle session to all Full Member Keene FSC skaters.

Subsequent Full Membership: \$75.00 Subsequent Full Membership is for a second (or subsequent) skating family member. All subsequent members have the privilege to participate in any exhibitions/events sponsored by the Club including Club parties, Annual Shows and Annual Skating Banquet (additional fees may apply). Keene Ice Arena has offered a \$1.00 off each contracted Freestyle session to all Full Member Keene FSC skaters.

Associate Membership: \$75.00 Associate membership is available to an individual who wishes to participate in club activities but is a full member of another club. This class of membership gives the privileges of participation in any exhibitions/events sponsored by the Club including Club parties, Annual Shows and Annual Skating Banquet at a **GUEST RATE**. Keene Ice Arena has offered a \$1.00 off each **contracted** Freestyle session to all Associate Member Keene FSC skaters.

Collegiate Membership: \$100.00 Collegiate membership is a full membership for any skater who is attending college. This membership is valid for 4 years and does not need renewing during that period. Collegiate members are permitted to participate in all exhibitions/events sponsored by the Club including Club parties, Annual Shows and Annual Skating Banquet (additional fees may apply). Keene Ice Arena has offered a \$1.00 off each contracted Freestyle session to all Full Member Keene FSC skaters.

Non-Skating/Board of Directors Membership: \$25.00 Available to parents and/or board members who wish to join the Keene FSC.

Full Coach Membership: \$85.00 Available to Coaches who teach on Keene Ice Learn to Skate and Keene Ice Figure Skating Sessions.
